Contributor Agreement: 'Kathmandu School of Law Review (KSLR)'

(hereinafter called "the Work with copyright agreement")

EDITORS, Kathmandu School of Law Review (hereinafter KSLR), Kathmandu School of Law, Purbanchal University, Nepal

(hereinafter called "the Editor", which expression shall where the context admits include the Editor's executor's administrators and assigns)

I, the undersigned (*hereinafter* called "the Contributor", which expression shall where the context admits include the Editor's executor's administrators and assigns) *hereby* agree to submit a Contribution to the above-entitled Work with Copyright Agreement.

The Work with Copyright Agreement shall be printed, published, marketed and sold by KSLR run under Kathmandu School of Law, Nepal (hereinafter called "The Publisher", which expression shall where the context admits include the Publisher's executors, assigns or successors in business as the case may be).

Now it is agreed as follows:

(1) The Contributor warrants and represents to the Editor that:

- (1.1) The KSLR will be the sole legal owner of the copyright in the Contribution and of all rights granted, and have the right, power and authority to make this Agreement;
- (1.2) The Contribution will be an original work that has not *hitherto* been published in any form and will in no way whatsoever give rise to a violation of any existing copyright, proprietary or personal right, or be in breach of any existing agreement;
- (1.3) The Contributor has not in any manner granted, assigned, encumbered or disposed of any of the rights herein granted to the Editor, or any rights adverse to or inconsistent therewith;
- (1.4) There are no rights outstanding which would diminish, encumber or impair the full enjoyment or exercise of the rights herein granted to the Editor;
- (1.5) The Contribution shall contain no obscene, libelous or unlawful content, content that violates any right of privacy, plagiarizes the work of others, or content that may be the cause of litigation;
- (1.6) The Contribution shall contain no defamatory or injurious statements or implication about living persons, institutions or other organizations that could result in libel claims;
- (1.7) To comply with strict Nepali data protection legislation, any personal data on living individuals used in the Contributor's research and included in the Work must been anonymized, or written consent from that individual be obtained. If it is not reasonably possible to obtain consent, the Contributor will notify the Editor of the specific instances no later than the delivery date set out above, in order that approval from the Publisher may be sought;
- (1.8) All statements within the Contribution purporting to be facts shall be true;

- (1.9) The Contributor shall cite others' work and their own previous work fully in the Contribution.
- (2) The Contributor agrees to obtain from the owners of any material in which the copyright is not their own written permission for the use of such material in all forms, including printed and electronic. The Contributor agrees to make any required acknowledgements and will pay any fees stipulated for this purpose. A written record of all transactions and agreements regarding copyright permissions shall be kept, maintained in good order, and sent to the Editor upon submission.

- (3) The Contributor agrees to indemnify and hold the Editor harmless against claims, demands, suits or action, proceedings, recovery or expense of any nature whatsoever arising from any claim or infringement of copyright or proprietary right or from claims of libel, defamation, obscenity, unlawfulness or invasion of privacy based upon or arising out of any manner or thing contained in the Contribution or from any breach of warranties and representations herein contained.
- (4) The Contributor hereby grants an exclusive license in the Contribution to the Editor and the Publisher for the full term of copyright and all renewals and extensions thereof and for all territories throughout the world. The Publisher shall have the exclusive right during such period to publish, and to license for publication, the Contribution in whole or in part in all editions, forms and media in the English language and in any translation without limitation.
- (5) The KSLR shall retain the copyright in the Contribution by Contribution and shall be exercised under *The Copyright Act*, 2059 (2002 AD), and:
- (5.1) May apply to the Publisher to use their own material written or compiled for the purposes of the Contribution, without charge, in articles submitted to learned or professional journals, in papers presented at professional conferences, for professional and teaching purposes generally and in any work that subsequently appears under their own name of sole or principal author or editor. The Publisher shall not unreasonably withhold permission provided the proposed use is not considered by the Publisher to be in competition with or likely to prejudice sales of the Work or exploit any of the rights granted to the Contributor under this Agreement and provided the complete Contribution shall not be the subject of any request. "Competition" means, for the sake of this Agreement, a work similar in organization, theme, content, title and intended audience. The Contributor shall make appropriate acknowledgement in accordance with academic custom and practice to the Work and Publisher;
- (5.2) May apply to the Publisher to use their Contribution in works that do not appear under their own name of sole or principal author or editor. In this event the Publisher may withhold permission or make a charge for using the material.
- (6) The Contributor agrees that at no stage is any version of the Contribution permitted to be posted online by the Contributor on commercial or free to access public servers, to institutional repositories or any other such site with public access.
- (7) The Publisher (i.e. KSLR) reserves the right to refuse to publish the Contribution if;

- (7.1) It is submitted to the Editor after the date agreed between the Contributor and the Editor;
- (7.2) In the Editor or Publisher's opinion the Contribution is of an unacceptable standard for publication.
- (8) The Contributor agrees that the Editor and Publisher may edit the Contribution to the extent reasonably necessary to reduce inconsistency of style within the Work. The Editor shall make the final decision on the inclusion or omission of the Contribution in or from the first and any subsequent editions of the Work.
- (9) It is acknowledged that the Publisher may publish the Work at its own expense, in such style and manner and at such price as it deems best suited to the sale thereof. The Publisher may make the manuscript conform to a style of punctuation, spelling, capitalization and usage is it deems appropriate.
- (10) The Publisher agrees to publish the name of the Contributor (and all co-authors to the Contribution) with due prominence at the beginning of the Work, at the end of the Contribution in the Work and wheresoever the Contribution is listed (for example, relevant content of promotional material and websites).
- (11) Upon publication of the first print edition of the Work, the Contributor shall be entitled to the following:
- (11.1) The Publisher undertakes to grant on-going access (personal not institutional) to the electronic edition of the Work to the Contributor.
- (12) The warranties, representations and indemnities shall survive the termination of this Agreement.
- (13) The terms set out in this document represent the complete Agreement between the parties and may not be altered save by a separate agreement in writing and signed by or on behalf of the parties.

Exclusive Jurisdiction Clause:

The Contributor hereby mutually agrees with the Publisher that, if any disputes arises in breach of this Agreement, the disputes shall be, to amicably resolve the disputes, exclusively referred to Courts of Nepal and shall be settled in accordance with laws of Nepal.
